**ORDINANCE - SETTING SALARIES OF BOARD MEMBERS**

Motion made by Ralph Maples, second by Carter McGlothlin and duly approved by the Board of Supervisors to approve the following ordinance:

PURSUANT TO SECTION 15.2-1414.3 be it ORDAINED by the Board of Supervisors of Russell County that upon motion duly made and carried as follows:

**AN ORDINANCE ESTABLISHING THE COMPENSATION OF THE  
MEMBERS OF THE RUSSELL COUNTY BOARD OF SUPERVISORS  
AND ITS CHAIRMAN AND VICE-CHAIRMAN FOR THE FISCAL  
YEAR JULY 1, 2002 - JUNE 30, 2003 PURSUANT TO SECTION  
15.2-404(D) AND 15.2-1414.1 ET SEQ OF THE CODE OF VIRGINIA, 1950**

WHEREAS, the county government of Russell County, Virginia is the "County Board Form of Government"; and,

WHEREAS, the compensation of the board of supervisors is governed by Section 15.2-404(D) of the Code of Virginia of 1950, as amended; and,

WHEREAS, by enactment of the General Assembly during the 2000 session counties operating pursuant to the "County Board Form of Government" were authorized and empowered to allow an annual salary pursuant to Section 15.2-1414.1 et seq. of the Code of Virginia of 1950, as amended; and,

WHEREAS, said enactment was signed into law by the Hon. Jim Gilmore, Governor of the Commonwealth of Virginia; and

WHEREAS, the population of Russell County, Virginia is not less than 25,000 nor more than 49,999; and

WHEREAS, after public hearing pursuant to notice in the manner and form as required by Section 15.2-1426 and 15.2-1427 of the Code of Virginia of 1950, as amended.

NOW THEREFORE BE IT RESOLVED:

**SECTION 1: TITLE**

This ordinance is known and is to be cited as:

COMPENSATION OF THE MEMBERS OF THE RUSSELL COUNTY BOARD  
OF SUPERVISORS AND ITS CHAIRMAN AND VICE-CHAIRMAN  
FISCAL YEAR JULY 1, 2002 -- JUNE 30, 2003

**SECTION 2: AUTHORITY**

This ordinance is adopted pursuant to the provisions and under the authority of Title 15.2, Chapter 4, Section 15.2-404(D) and Chapter 14, Article 1.1, Section 15.2-1414.1 and 15.2-1414.3 of the Code of Virginia of 1950, as amended.

**SECTION 3: EFFECTIVE DATE**

The effective date of this Ordinance shall be July 1, 2002. This Ordinance shall terminate on June 30, 2003.

**SECTION 4: ESTABLISHMENT OF SALARIES**

1. Annual salaries for board members shall be \$7,000.00
2. In addition to the annual salary of \$7,000.00 the chairman of the board shall receive, annually, an additional sum of \$1,800.00.
3. In addition to the annual salary of \$7,000.00 the vice-chairman of the board shall receive, annually, an additional sum of \$1,200.00.

**SECTION 5: FRINGE BENEFITS**

In addition to and without regard for the salary limits herein set out, the board of supervisors by resolution may grant to its members any or all of the fringe benefits in the manner and form as such benefits are provided for county employees.

SECTION 6: INFLATION FACTOR

The annual salaries herein provided may be adjusted in any year or years, by ordinance, on a date determined by the board of supervisors, not earlier than May 1, nor later than June 30 each year, after public hearing pursuant to notice in the manner and form provided in Section 15.2-1426 and 15.2-1427, by an inflation factor not to exceed five (5%) percent.

RESOLUTION - REVENUE ANTICIPATION NOTE

WHEREAS, the Board of Supervisors (the "Board") has determined that it is necessary and expedient to borrow up to \$5,000,000 and to issue its General Obligation Revenue Anticipation Note, Series 2002 ("Note") therefore to meet casual cash flow deficits of the county; and

WHEREAS, \$5,000,000 will not exceed the anticipated revenues for the fiscal year ending June 30, 2003; and

WHEREAS, the Note would mature and be paid within one year from the date of issue; and

WHEREAS, there are no anticipated extensions of Notes from previous years; and
