A service charge, which shall be the lesser of four percentum of the amount of tax or the amount charged to Russell County for the use of such card, shall be imposed for acceptance of such card. Such service charge shall be in addition to, and not in lieu of, any penalties and interest arising pursuant to Sections 58.1 through 58.1-3918 of the Code.
