

Furthermore, we see no verification for the director of the vocational training facility to hold a certificate as a Registered Professional Hairdresser. The cosmetology program is under the direct supervision of a registered professional cosmetologist who is a certified teacher. The director of the school should meet certification regulations as adopted by the State Board of Education since he is responsible for the overall supervision and administration and does not have instructional contact with students in the program.

Furthermore, it is the consensus of the Russell County Board of Supervisors that this proposal has been designed to eliminate the cosmetology program as presently constituted from the public schools of Virginia since no substantial evidence has been presented to justify increasing the hours in the training program.

Furthermore, the proposals seem to be designed to eliminate competition from the beauty industry and to concentrate training and certification in the hands of a few private schools and individuals.
