PUBLIC HEARING ON
AMENDMENT TO THE MOTOR VEHICLE
AND TRAFFIC CODE ORDINANCE

Public hearing was held pursuant to law and having been advertised in the Lebanon News for two successive weeks.

Motion was made by Danny Brown and unanimously approved by the Russell County Board of Supervisors that ordinance to amend the MOTOR VEHICLE AND TRAFFIC CODE ORDINANCE effective July 1, 1983, be adopted.

ORDINANCE

An ordinance to adopt State laws regarding motor vehicles and traffic; Pursuant to the Authority of Section 46.1-188 of the Code of Virginia, (1950 as amended), all of the provisions and requirements of the laws of the State contained in Title 46.1 of the Code of Virginia (1950 as amended), except those provisions and requirements the violation of which constitutes a felony, and except those provisions and requirements which by their very nature can have no application to or within the County, and the provisions of Article 9

hereby adopted and incorporated in this Chapter by reference and made applicable within the County. References to, "highways of the State" contained in such provisions and requirements hereby adopted shall be deemed to refer to the streets, highways and other public ways within the County. Such provisions and requirements are hereby adopted, mutatis mutandis, and made a part of the Chapter as fully as though set forth at length herein; and it shall be unlawful for any person, within the County, to violate or fail, neglect or refuse, to comply with any provision of the Title 46.1 of the Code of Virginia (1950 as amended) or Article 2 Chapter 7, of Title 18.2 of the Code of Virginia (1950 as amended), which is adopted by this section, provided, that in no event shall the penalty imposed for the violation of any provision or requirement hereby adopted exceed the penalty imposed for a similar offense under Title 46.1 of the Code of Virginia (1950 as amended), or Article 2, Chapter 7 of Title 18.2 of the Code of Virginia (1950 as amended).

PUBLIC HEARING ON FY 83-84

BUDGET

Public hearing was held pursuant to law after having been advertised in the Lebanon News for two successive weeks.

James Gillespie, County Administrator presented the County Budget and gave a brief synopsis of proposed Fiscal Year 83-84 Budget in the amount of \$3,724,945.

Charles Long, Superintendent of Schools, presented the proposed School Operating Budget for FY 83-84 and gave a brief synopsis of same. School Capital Outlay and Debt Service Fund proposed 83-84 FY budget in the amount of \$7,174,769. Operating Budget proposed amount \$15,057,873.

Public was invited to speak.

R. D. Snead asked that the Board approve \$150,000. for the Russell County Fair Association in the coming 83-84 FY Budget.
