On motion of Mr. Puckett, seconded by Mr. Rasnake, which carried 7:0, the following ordinance was adopted:

**AMENDMENT TO THE RUSSELL COUNTY ORDINANCE TO  
ESTABLISH POLLING PLACES**

WHEREAS, on May 2, 2011, the Russell County Board of Supervisors adopted An Ordinance to Name Each Election District; to Establish Boundary Lines of the Election Districts; to Name Each Precinct; to Establish a Polling Place for Each Precinct; to Establish Boundary Lines of Election Precincts; and to Establish a Central Absentee Voter Precinct for Russell County, Virginia ("Ordinance");

WHEREAS, Article 1(A)(3) of Chapter 3 of the Ordinance establishes that South Castlewood Precinct's polling place shall be 304 Blue Devil Circle at the Castlewood High School;

WHEREAS, Article 1(B)(1) of Chapter 3 of the Ordinance establishes that North Castlewood Precinct's polling place shall be 304 Blue Devil Circle at the Castlewood High School;

WHEREAS, Article 1(C)(3) of Chapter 3 of the Ordinance establishes that Daugherty Precinct's polling place shall be at 4046 River Mountain Road at the Oak Grove Church;

WHEREAS, the Russell County Board of Supervisors has determined that it has become necessary that the polling places of these precincts be moved;

NOW, THEREFORE, BE IT RESOLVED AND ORDAINED that Articles 1(A)(3), 1(B)(1) and 1(C)(3) of Chapter 3 of the Ordinance shall be amended to read as follows:

1. Article 1(A)(3) shall be amended to:

South Castlewood, No. 0103-2010, whose polling place shall be 304 Blue Devil Circle at Castlewood High School. The actual polling place shall not be in the same room or adjacent to the room used by voting by the registered voters of the North Castlewood, No. 0201-2010 precinct.

2. Article 1(B)(1) shall be amended to:

**North Castlewood, No. 0201-2010**, whose polling place shall be 304 Blue Devil Circle at Castlewood High School. The actual polling place shall not be in the same room or adjacent to the room used by voting by the registered voters of the South Castlewood, No. 0103-2010 precinct.

3. Article 1(C)(3) shall be amended to:

Daugherty, No. 0302-2010, whose polling place shall be at 327 River Mountain Road, Lebanon, Virginia 24266, at the Glade Hollow Ball Park.
