AMENDED ORDINANCE - SUNDAY SALE OF BEER, ETC.

Upon motion made, seconded and duly passed the Board hereby amends ordinance passed November 5, 1945, recorded in Supervisor's Order Book No. 8 page 323, and to become effective on or after 12-14-45, in regard to Sunday sale of beer or wine be and the same hereby is amended to read as follows:

"Be it ordained by this Board that no person licensed as a retailer of beer or wine under the Alcoholic Beverage Control Act of Virginia shall sell or offer for sale, to any person in the bounds of Russell County, Virginia, except in incorporated towns, any beer or wine between the hours of twelve o'clock post meridian of each Saturday, and six o'clock ante meridian on each Monday; provided, however, that this amended shall not apply to private clubs. -----"

Repealed during the November 3, 2025, Russell County Board of Supervisors meeting, effective immediately.

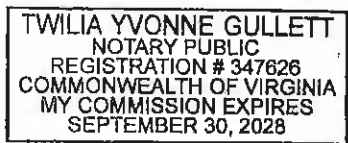

This motion having been made at a former meeting of this Board and the adjoining landowners duly summoned to appear at this meeting, upon motion, and by agreement of the parties concerned, it is ordered that Burke Whitt, Luther Hale and O. H. Whitt, resident freeholders of this county, be, and they hereby are appointed as viewers to view the said section of road asked to be abandoned, and report their findings as required by law. After going upon the premises and viewing same the said commissioners returned and made their report as follows:

"We, O. H. Whitt, Burke Whitt, and Luther Hale, commissioners appointed by the Board, after having gone upon the premises and after having considered the advantages and disadvantages of closing said road to all parties concerned, are of the opinion that said section of road should be left open as it now is, and no part should be abandoned.

O. O'Connell's, intersecting with the road from Fletcher's to Dickensonville, upon motion, it is ordered that Ernest Sexton, Charles G. Dickenson, Robert Robinson, Mrs. Tom Price, J. H. Robinson, Clarence Robinson, Ed Robinson and E. G. Harding, landowners along said road remove all gates and other obstructions on said road within 60 days from ~~xxxxxx~~ this date.

ORDINANCE: SUNDAY SALE OF BEER ETC.

Be it ordained by this Board that No person licensed as a retailer of beer or wine under the Alcoholic Beverage Control Act of Virginia shall sell or offer for sale, to

any person in the bounds of Russell County, Virginia, except in incorporated towns, any beer or wine between the hours of twelve o'clock, post meridian of each Saturday, and six o'clock Ante Meridian of each Monday. Any person found guilty of any violation of this ordinance shall, upon conviction thereof, be punished by a fine of not less than \$10.00 nor more than \$100.00 or by confinement in jail for a period of not less than 30 days, either or both such fine or imprisonment in the discretion of the court or jury trying the case.

This ordinance shall be effective on and after the 14th day of December, 1945, and the Clerk of this Board shall cause a copy of this resolution to be published in the next two successive issues of the Lebanon News, as required by law.

TRANSFER OF SCHOOL FUNDS

Upon motion, it is ordered that the Treasurer be, and he is hereby, directed to transfer the sum of \$32,000.00 from the General County Fund to the County School Fund, this being the balance of the appropriation made by this Board for School Purposes.
